## Scope of Work and desired outcome:

- 1. Marketing Agency LSF will contract with PR firm to implement Anything but Obvious media campaign through print, radio, tv, social media, and billboards.
  - **Desired Outcome**: increase community awareness and decrease stigma in seeking help for OUD.
- 2. radKIDS Personal Empowerment Educational initiative not only provides personal skills for the children and educators of the program but has proven to enhance overall school safety by creating a safer school climate. One that enriches and enhances the overall school culture reducing conflict and fear and replacing it with the opportunity.
  - **Desired Outcome:** Students can focus on learning instead of fear, and the teachers are able to focus on teaching and empowering their students instead of spending their time in class and behavioral management.
- 3 CORE Coordinated Opioid Recovery Establish a team comprised of a paramedic, behavioral health clinician, case manager and peer coach to engage with individuals under a Mobile Integrated Health (MIH) Community Paramedicine model.
  - **Desired Outcome:** To offer addiction intervention in a non-judgmental, compassionate, caring support manner and increase access to ethical treatment options.
- 4 Establish Mobile MAT program to provide outpatient medication and counseling to underserved communities, purchase vehicle, recruit, hire, train and onboard staff Identify areas of high need to determine locations and schedule. Provide buprenorphine, peer support and outpatient services in the specified communities on a planned schedule.
  - **Desired Outcome:** increase # of individuals receiving MAT.
- 5 Expand MAT service availability and coordinate with the Alachua County Fire Rescue (ACFR) CORE Program to provide longer term treatment and recovery support.
  - **Desired Outcome:** increase # of individuals receiving MAT.

6 Vendor – Contract to provide fixed and mobile vending machines to increase the availability of Narcan in locations with high overdose response as well as for events that may be linked to the possibility of increased overdose potential.

**Desired Outcome**: reduce deaths by overdose.
