Town of Davie Implementation Plan FY25 Summary

2. Needs Assessment

- **Data Analysis:** Review current trends with opioid-related Emergency Medical Services calls with fire rescue. Review local crime statistics related to opioid use, such as drug trafficking, thefts, and overdoses.
- **Resource Inventory:** Assess current law enforcement and fire rescue capabilities, emergency response resources, and community safety programs to identify gaps and needs.

3. Strategic Priorities

- Training and Resources:
 - **TDFRD Training Programs:** Provide comprehensive training on handling opioid-related incidents, including identification, and train on advanced patient assessment techniques.

 TDFRD Equipment and Technology: Supply fire rescue with necessary equipment, such as protective gear, overdose kits (naloxone), advanced drug detection technology, advanced training techniques, and advanced real-life mannequins to provide scenario-based training.

• Emergency Response and Overdose Prevention:

- TDFRD: Continue to equip TDFRD personnel with the latest and most upto- date equipment to exceed industry standards as it pertains to emergency overdoses.

- **Community Outreach:** Conduct public education safety campaigns to educate the community on overdose prevention and reporting suspicious activities. Provide a brief summary of Narcan administration during TDFRD monthly CPR classes.

- **Collaboration:** Foster partnerships with surrounding law enforcement, fire rescue, public health agencies, and community organizations to ensure comprehensive and coordinated efforts.

6. Monitoring and Evaluation

- Overview: Quarterly financial and performance reporting will be conducted to ensure the effectiveness of this funded program. TDFRD will oversee this monitoring. Comprehensive performance reports, detailing progress, challenges, outcomes, and any necessary adjustments to the implementation plan, will be submitted to the Town's Finance and Legal Department. This rigorous evaluation process will ensure accountability and continuous improvement of the program.
- **Regular Reporting:** Require quarterly reports from funded programs to monitor progress and make data-driven adjustments.
- **Evaluation:** Conduct an annual review to assess the effectiveness of funded initiatives and identify areas for improvement.

Conclusion This implementation plan provides a comprehensive approach to utilizing the opioid settlement funds in a manner that aligns with the stipulations of Schedules A and B.
