D. Address the Needs of Criminal-Justice-Involved Persons

o **Amount:** \$4,574.00

O Description: Funding will be used to contract with a community-based organization to provide educational workshops for incarcerated individuals who are also impacted by the opioid epidemic. Curriculum offers empowerment skills and teaches participants how to gain self-compassion to address substance use. Twice monthly, community outreach including education, resources, and Narcan will be available to friends and family members of those who are incarcerated.

o **Amount:** \$25,407

- Description: Funding will be used to purchase a monitoring and surveillance system for the Gainesville Police Department's Drug Task Force Team facility. This facility houses evidence collected in cases involving substances. This purchase also includes an electrical conduit.
