- Description: Equip law enforcement officers with a handheld spectrometer device, which will allow them to safely field-test suspected opioids and other suspected harmful controlled substances.

- **Capital Outlay:** Purchase of TRUNARC device.

# 3. Law Enforcement and First Responders (Harm Reduction)

- **Amount:** \$4,467
- **Description:** Equip law enforcement officers with two full-frame interchangeable lens cameras to be used during fentanyl distribution investigations and harmful controlled substance evidence collection.
- Hiring: N/A

- **Capital Outlay:** Purchase of two Sony Alpha 7 IV cameras.
- Vehicle Purchases: N/A

# 4. Law Enforcement and First Responders (Harm Reduction)

- **Amount:** \$12,500
- **Description:** Equip law enforcement officers with a device that will give investigators the ability to access and extract evidence from mobile devices during fentanyl distribution investigations, to include overdose death investigations.

- **Capital Outlay:** Purchase of Magnet Graykey device.
- Vehicle Purchases: N/A

# 5. Law Enforcement and First Responders (Harm Reduction)

- **Amount:** \$7,000
- **Description:** Equip law enforcement officers with field-test drug poches to be used while safely detecting the presence of controlled substances, to include fentanyl and other opioids.
- Hiring: N/A
- **Capital Outlay:** Purchase of DETECTACHEM multi-drug test pouches.
- Vehicle Purchases: N/A

# 6. Law Enforcement and First Responders (Training)

- **Amount:** \$10,000
- Description: Train law enforcement officers in the most effective ways to respond to and investigate overdose death cases. In addition, training will be implemented to train investigators on the best practices in conducting drug investigations, to include investigations focusing on the sale and distribution of fentanyl and other opioids.
