Scope of Work and desired outcome:

- 1. **Santa Rosa County / FLDOH in Santa Rosa County** Increase availability and distribution of naloxone and other drugs that treat overdoses for first responders, particularly volunteer fire departments throughout Santa Rosa County. <u>Desired outcome:</u> Increase access to, and availability of, life-saving drugs for use by first responders.
- 2. **Santa Rosa Sheriff's Office / Lakeview Center, Inc.** Establishment of an MAT program in Santa Rosa County jail, to include follow-up support services in Santa Rosa County to reduce recidivism and provide tools for criminal-justice-involved persons to continue treatment and recovery services following criminal justice involvement. <u>Desired outcome:</u> Increase distribution of MAT to incarcerated individuals and increase access to necessary support services following criminal justice involvement.



3. **Florida Department of Health in Santa Rosa County** – Continuation of an existing, but currently unfunded, prevention program targeting school-aged youth concerning opioid misuse and opioid use disorder (OUD). <u>Desired outcome</u>: Provide education programs to prevent the uptake and use of opioids among youth in Santa Rosa County.
